You must have a Business, Trade, or Occupation License for the privilege of engaging in and carrying on, within the City of Frontenac, any business, trade, or occupation not otherwise exempted by the provisions of Section 71.62 RSMo. No person, firm, corporation, association, or partnership, nor any two or more persons engaged in any joint enterprise shall engage in or carry on any business, trade, or occupation without having first obtained a license. This statement is to be used to establish gross annual sales, receipts, or business for the previous calendar year. The tax for a business, trade, or occupation license is based on One Dollar (\$1.00) per One Thousand Dollars (\$1,000.00) of gross sales, receipts, or business. **The minimum tax is One Hundred Dollars (\$100.00) per annum, or \$35.00 for a home occupation with sales under \$1000.** You are required to file this statement and make full payment of your calculated tax on or before April 15th. Please note the financial penalties below for late filing and/or deficiencies.
