- 1. <u>Bill No. 2018-1880</u>: An ordinance of the City of Frontenac, Missouri, to amend the Municipal Code or Ordinances by enacting a new section 220.370 prohibiting constructive invasion of privacy in the City; enacting a new chapter 260 entitled miscellaneous regulations and a new section 260.010 therein title regulation of unmanned aircraft systems thereby providing for the regulation of unmanned aircraft systems within the City of Frontenac, Missouri.
