

**AN ORDINANCE AUTHORIZING AN AMENDMENT TO AN AGREEMENT WITH GATEWAY DISPOSAL, LLC, TO INCREASE MONTHLY FEES IN ORDER TO HELP OFFSET UNANTICIPATED FUEL COSTS.**

**WHEREAS**, the Board of Aldermen of the City of Frontenac approved a five-year contract with Gateway Disposal, LLC ("Gateway") running from January 1, 2020 through December 31, 2024; and

**WHEREAS**, the cost of diesel fuel has increased substantially over the amount Gateway had anticipated over the past year; and

**WHEREAS**, Gateway has asked the City to consider approving an increase to the monthly fee for service to help offset some of the cost increase, and

**WHEREAS**, Gateway has provided a high level of service to Frontenac residents and at a much lower rate than competing trash haulers; and

**WHEREAS**, The total cost per household in the City's original agreement with Gateway was \$27.32 per month for calendar year 2023 and was \$27.87 per month for calendar year 2024.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FRONTENAC, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:**

**SECTION ONE:**

The Mayor is hereby authorized to enter into an amended agreement ("Agreement") on behalf of the City of Frontenac, Missouri, with Gateway Disposal, LLC to provide trash collection and disposal services for residents of the City of Frontenac on terms consistent with those stated above and in form approved by the Mayor and City Attorney.

**SECTION TWO:**

The following documents will become attachments to and be incorporated into the Agreement:

1. City of Frontenac Request for Proposal for Residential Solid Waste,

- Recyclables, Yard Waste and Bulky Collection, Hauling, Processing and Disposal (Contract Specifications).
2. Gateway's proposal bid proposal form, and all documents submitted with Gateway's proposal.
  3. The Amended Agreement between Gateway and the City of Frontenac.

**SECTION THREE:**

This ordinance shall be in full force and effect immediately upon its passage by the Board of Aldermen and its approval by the Mayor.
