P. UNFINISHED BUSINESS:

1. <u>Reconsideration of Bill NO. 2024-2099</u>: An ordinance adopting a new section of the Frontenac City Code establishing the "BD" Business District Zoning District and enacting regulations pertaining thereto and amending Section 405.020 to include the "BD" Business District.

Pursuant to Sec. 79.140 RSMO. and Sec. 110.130 of the Frontenac City Code, Mayor Hatfield declined to approve Bill 2024-2099 as passed by the Board of Aldermen on February 19, 2025, and has returned the Bill with her objections, which are attached hereto and hereby made a part of the record. In accord with the referenced statute and code provision, the Bill, therefore, now shall stand reconsidered. The Board is to proceed at its convenience to consider the question: **Shall the bill pass, the objections of the mayor thereto notwithstanding?**

Upon reconsideration, if two-thirds of all the members-elect shall vote in the affirmative, the Bill shall become an ordinance in the same manner and with like effect as if it had received the approval of the mayor.
