POLICE ACTIVITY REPORT FOR NOVEMBER 16-30, 2025

11/16/25	Abandoned Auto	An abandoned vehicle was towed from the parking lot of 1701 S Lindbergh Blvd at the request of the business.
11/18/25	Disturbance	Officers responded to a residence on Vouga Ln for a domestic disturbance that just occurred. It was determined that a verbal argument occurred at the residence and one of the subject's left in a vehicle. The subject was later arrested by Ladue PD for charges related to a firearm.
11/18/25	Domestic Assault	Officers responded to a residence on Terrace Gardens Ln for a domestic disturbance. It was reported that one of the subjects threw food on the other person during an argument. Each of the parties were separated and the incident was forwarded to the Frontenac Prosecuting Attorney to review for possible charges.
11/19/25	Traffic Arrest	A traffic stop was conducted in the area of the EB I-64 and S Lindbergh Blvd. The vehicle originally tried to speed up to evade the officer but eventually came to a stop. The subject was later arrested for speeding, no insurance, and no driver's license.
11/20/25	Larceny	A business at Plaza Frontenac (1701 S Lindbergh Blvd) reported a shoplifting that had occurred earlier that day. During the theft, a male subject stole a handbag by concealing it under his coat. This case is currently under investigation.
11/22/25	Larceny	The Creve Coeur Police Department notified this agency during a stolen vehicle investigation; numerous clothing items were discovered that appeared to be stolen from business at Plaza Frontenac. Further investigation was conducted and determined that theft occurred at a business the previous day on 11/21/25. The subject, arrested by Creve Coeur PD for the stolen vehicle, was determined to be the larceny suspect as well. This case will be forwarded to the St. Louis County Prosecuting Attorney's Office for charges.
11/22/25	DWI Arrest	Officers responded to the area of the 10400 block of Clayton Rd for a vehicle crash. It was later determined that one of the drivers involved in the crash was intoxicated. The subject was arrested for driving while intoxicated.
11/23/25	Sudden Death	Officers were dispatched to a residence on Cricklewood PI for report of a sudden death. The St. Louis County Medical Examiner's Office later arrived on scene to complete their investigation, and the body was released to them.
11/24/25	Investigation	An officer received a phone call to report a crime that happened over the internet. It was later determined that the crime occurred in another jurisdiction. The case was transferred to another agency for follow up.
