A. CALL TO ORDER

D. VOTE TO APPROVE AGENDA:

G. ADMINISTRATOR'S ADDRESS:

H. OLD BUSINESS:

1) Project Updates:

a. Geyer Road Phases:

1. Phase 1: Mr. Wappelhorst stated that Platin Creek Excavating (PCX) is installing storm drains at Geyer Downs, along with prepping the remainder of the project.
2. Phase 2 & 3: Mr. Wappelhorst stated that the City has received approval to start meeting with property owners for right-of-way compliance paperwork and is near completion.

b. Spoede Bridge:

Mr. Wappelhorst stated Missouri American Water has started the process to bore a new water main on the west side of Spoede to replace the water main that is currently on the bridge.

c. MoDOT:

1. Lindbergh Bridge over Deer Creek: Spire Gas has advised that the gas main is being relocated which will close one (1) northbound lane at German and the left turn lane into westbound German. Traffic wanting to

access German will be routed to the U-turn Lane at Chaminade.

d. Countryside Storm Water Project:

Mr. Wappelhorst stated the project is proceeding and we hope to hit the sod window tomorrow and Friday. We have three (3) crews working.

e. Gold Dust:

The project is completed.

f. North & West Geyer Road Stormwater Project:

EDM is compiling residents and trustees concerns and putting together a plan. We should know more towards the beginning of the year.

g. East-West Gateway Council of Government / MoDOT:

Mr. Wappelhorst stated the anticipated improvements will involve roadway resurfacing, new curbs and gutters on both sides of the road, storm water drainage improvements, new concrete crosswalk on the southside of Clayton Road, and installing curb ramps to meet ADA requirements. This is going to the Board of Aldermen next week for approval.
