

# MINUTES OF THE PLANNING AND ZONING COMMISSION FRONTENAC CITY HALL - 10555 CLAYTON ROAD MONDAY, FEBRUARY 10, 2025, 6:00 PM

A. **CALL TO ORDER:** The regular meeting of the Planning and Zoning Commission was called to order at 6:00 p.m. by Chairperson Kim Tompras.

# C. **APPROVAL OF AGENDA:**

#### I. NEW BUSINESS:

1. <u>PZ102224-01</u>: Request from Cory Spence with Grimes Engineering for Approval of a Preliminary Subdivision Plat at 11321 Conway Road in the R-1 One-Acre Residence District.

Mr. Cory Spence of Grimes Engineering introduced himself to the commission members and offered to answer any questions.

Ms. Rottjakob stated that the applicant is interested in requesting this approval, both preliminary and final, to be forwarded to the Board of Alderpersons.

Mr. David Fairgrieve, Building Commissioner, stated that Oetjen Lane is a private lane. He stated that he does not believe the owner will grant access to the property off his lane. The owner will have to enter from Conway Rd.

Mr. Joe Sunderman, 4 Vouga Lane, stated that there is an easement on his property also. He disagrees that Oetjen Lane is privately owned, he did state that he is required to maintain it.

Mr. O'Keefe stated that he hasn't seen any of the documentation in regards to the easement, but an easement is a right to use private property, so it is a use someone else's property and it doesn't make that other property public it means that more than one person has the right to use it for the purpose of the easement and the owner is entitled to use it in anyway that does not interfere with the rights of the easement holder so it continues to be private property. It is not a street dedicated to public use and it is not a street in the City's subdivision code.

Ann Hendrich, stated that she would like to share the same comments in regard to the driveways and possibly sidewalks and would like to know what will have to happen to

help slow traffic down to this approach. She also asked within City of Frontenac guidelines and regulations, whether there is a limit or maximum for these new house valuations.

Mr. Fairgrieve stated there are maximum building setback and height requirements and a minimum square footage. Mr. Fairgrieve stated he has not seen a permit or building plan for the property yet. He stated tonight's meeting was strictly requesting the lot be split into two equal lots.

Mr. O'Keefe reported that both the Commission and Board of Aldermen have very limited discretion and these lots do meet the standard minimum zoning codes within the City of Frontenac.

<u>MOTION</u>: Mr. Kehr made a motion to approve the preliminary and final subdivision plat at 11321 Conway Road in the R-1 One-Acre Residence District. All commission members voted "Aye"; the motion passed unanimously.
