

# MINUTES OF THE CITY OF FRONTENAC BOARD OF ALDERPERSONS APRIL 26, 2021 SPECIAL MEETING VIA VIDEO CONFERENCE

The April 26, 2021, special meeting of the Board of Alderpersons of the City of Frontenac was called to order at 4:08 p.m., by Mayor Kate Hatfield. The Board of Alderpersons present were Dan Millman, Nalini Mahadevan, Jamie Griesedieck, and Tom O'Brien (all participated via video conference). Alderperson Dan Kemper and Brian Warner were absent.

#### A. **CALL TO ORDER**

Mayor Hatfield called the meeting to order.

#### B. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was stated by everyone.

## C. VOTE TO APPROVE AGENDA

**MOTION:** Alderperson Milliman made a motion and Alderperson O'Brien seconded to approve the meeting agenda. All Alderpersons voted "Aye". Motion passed.

#### D. **UNFINISHED BUSINESS:**

First reading occurred on April 20, 2021.

1. <u>Bill No. 2021-1988</u>: An ordinance reinstating salary step increases for all employees for fiscal year 2020-2021.

<u>MOTION</u>: Alderperson O'Brien made a motion and Alderperson Millman seconded to remove Bill No. 2021-1988 from the table. All Alderpersons present voted "Aye". The vote was unanimous. **MOTION PASSED.** 

Mr. Christensen presented additional information on this bill. There was discussion by the Board of Alderpersons.

<u>MOTION</u>: Alderperson O'Brien made a motion and Alderperson Griesedieck seconded for a second reading of Bill No. 2021-1988. All Alderpersons present voted "Aye". The vote was unanimous. **MOTION PASSED.** 

<u>Bill No. 2021-1988</u>: An ordinance reinstating salary step increases for all employees for fiscal year 2020-2021.

Mayor Hatfield asked for a motion to approve Bill No. 2021-1988.

**MOTION:** Alderperson O'Brien made a motion and Alderperson Griesedieck seconded approval of Bill No. 2021-1988.

Mayor Hatfield asked Ms. Ross to call the roll.

**ROLL CALL VOTE:** Alderperson Millman, Alderperson Mahadevan, "Aye"; Alderperson Griesedieck, "Aye"; and Alderperson O'Brien, "Aye". The vote was unanimous. **MOTION PASSED** by a vote of 4-0.

## Bill No. 2021-1988 became Ordinance No. 2021-1942.

2. Continue discussion to begin the contract with H3 Studio Inc., for the comprehensive plan.

The discussion continued on this topic, for to the need to begin the comprehensive plan at this time, due to numerous future development projects within the city.

**MOTION:** Alderperson Millman made a motion and Alderperson Mahadevan seconded to authorize a notice to proceed with H3 Studios for the comprehensive plan. All Alderpersons voted "Aye". Motion passed.
