I. **NEW BUSINESS:**

1. <u>PZ072721-01</u> Request approval of a Conditional Use Permit to operate a day care center at 11155 Clayton Road. (Zoned PDR)

Mr. Morgan stated that this location has had a couple schools, day care centers and nurseries. This is for a new day care center at the same location. Mr. Jesse Harper is the owner/occupant. Mr. Harper said this is the second location, the other location is in the south city/Hampton neighborhood. Ms. Tompras questioned the number of children, staff, operating hours, etc. Mr. Morgan stated the schools were allowed 50-100 children for elementary. Mr. Harper stated the current capacity is 20. Alderperson O'Brien asked if the capacity is 30-35 children, should the applicant request that this time. Mr. Harpers stated he currently has approval for 20. He said he will provide child care services for children ages 0-3 years of age. He said they may later add ages 3-4.

MOTION: Ms. Tompras made a motion and Ms. Hartwig made a second for the approval and referral to the Board of Alderpersons for a conditional use permit as approved with conditions for Sprout Montessori West to operate a day care center at Des Peres Church, 11155 Clayton Road, zoned PDR. All Commission members present voted "Aye". Motion passed by a vote of 7-0.
