I. **NEW BUSINESS:**

1. **PZ07113021-01**: Request approval of a preliminary subdivision plat for the property located at 10316 Anzeiger Drive. Zoned R-2

Ms. Rottjakob stated the applicant is Mark Manlin who is proposing to consolidate lots which will be $62 \frac{1}{2}$ feet wide. A single-family residence has been demolished and there are plans to develop a new single-family residence. There was one single family home on the lot prior to demolition.

2. <u>**PZ07113021-02**</u>: Request approval of a preliminary subdivision plat for the property located at 10408 Anzeiger Drive. Zoned R-2

Ms. Rottjakob stated the applicant for this project is also Mark Manlin. This parcel is 50 feet wide. She said it is impossible to make it a 75-foot lot. She said both lots are non-confirming lots. If approved by the Planning & Zoning Commission, there will be a recommendation for approval that will need to go to the Board of Alderpersons.

Mr. Watkins asked for approval of both items in one motion.

MOTION: Mr. Kehr made a motion and Mr. Bauer made a second for the approval and referral to the Board of Alderpersons of a preliminary subdivision plat for the properties located at 10316 Anzeiger Avenue and 10408 Anzeiger Avenue, zoned R-2. All Commission members present voted "Aye". Motion passed by a vote of 8-0.
