The above services will be provided for the City of Frontenac. Our event fee for the above services would be \$2,500.00. The City of Frontenac is working to obtain grant funding in the amount of \$10,000.00. Of this funding, mobilization fees will be taken out first, which leaves \$7,500.00 to cover the fees for negative value materials. Once this remaining \$7,500.00 has been depleted, each individual dropping off their material will pay the recycling fees for certain items, (see attached document).

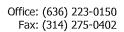
