Reflecting on the past year, I am delighted to highlight the collective achievements realized through the concerted endeavors of our all-volunteer Board of Aldermen, the contributions of appointed

volunteers within our Commissions and Committees, and the unwavering commitment of our city hall staff. I also want to recognize the kindness and generosity of Frontenac residents and the mayor, Board of Aldermen, and Crystal Lake Park residents for supporting Officer Newton's family with donations to the Go-Fund-Me Account and the 529 education fund for his children, the memorial bench in Hunter Park and for support the December fundraiser sponsored by the Frontenac Town & Country Chamber of Commerce at Stretch Lab.

Strategic prioritization, particularly our steadfast dedication to upholding exemplary city services, underscores numerous commendable outcomes attained this year. Noteworthy accomplishments encompassed the police department maintaining impressive clearance rates while the fire department sustained superior response times, surpassing national averages. Our proactive integration of innovative technologies, such as flock cameras, and collaboration with neighboring police departments, have significantly contributed to maintaining low crime rates, surpassing both national benchmarks and Frontenac's goals.

The fire department's trajectory aligns with an enhanced training program aimed at exceeding the next ISO review benchmarks, while both fire and police departments remain steadfast in their succession planning initiatives. In the realm of the building department, strides have been made to streamline building permit cycle times and heighten the resolution of code violations. Notably, cohesive

2021 International Building Codes

We are excited to announce that on January 30th, the city officially adopted the 2021 International Building Codes (IBC). This decision was preceded by a mandatory 90-day waiting period, allowing sufficient time for the public to review and provide feedback regarding these technical codes. We want to thank everyone who participated and shared their valuable insights during this process.

Building codes are vital laws that establish minimum requirements for the design and construction of residential and commercial buildings.

Regular updates to these codes, typically every three years, ensure the safety of occupants and the structural integrity of buildings. With this adoption, our community will be up-to-date with the latest industry standards and best practices.

The transition to the 2021 International Building Codes represents a significant step forward for our city. These codes take into account advancements in technology, engineering, and our understanding of natural hazards and human behavior. By embracing these codes, we are prioritizing the safety and resilience of our buildings.

It's important to note that the adoption of these codes was not a simple copy-and-paste process. We carefully considered the unique needs of our community and incorporated a variety of local amendments. These amendments ensure that the codes align with our specific requirements and reinforce the security of our buildings.

We understand that change can sometimes raise questions or concerns. If you have any inquiries or require further information regarding this transition, we encourage you to contact our Building Department at 314-994-3200. Our knowledgeable staff is ready to assist you should you require it.

Fiscal 2023 in Review and the FY 2024 Budget

The city concluded its fiscal year (FY) on a positive note, surpassing initial projections and outperforming the previous year. During FY23 (July 1, 2022, to June 30, 2023), the resurgence of sales tax and associated revenues exceeded budgeted estimations. Strategic adjustments in managing city reserves, including their placement in the Missouri Securities Investment Program (MOSIP), also contributed significantly to the upswing in revenues. There was an impressive 11.5% increase in revenues, amounting to \$3,122,542 compared to the preceding year.

The primary operational fund, the General Fund, ended the fiscal year with a balance of \$11,064,162, marking a \$2,225,686 increase from the previous year and persisting in its year-over-year progress compared to the pre-pandemic balance of \$13,077,098 in 2019. The fund balance ratio escalated to 141%, a significant advancement from the prior year's 105%. Notably, the unassigned fund balance reached \$10,733,204 by the end of the fiscal year, predominantly propelled by a substantial uptick in investment income with a 7% rate of return. Concurrently, the surge in sales tax revenues mirrors the ongoing recuperation from the pandemic, bolstered by the use tax expansion to encompass all online sales and the addition of new retail businesses. It is essential to highlight that some of these funds are earmarked for infrastructure enhancements that are currently in process.

The Stormwater Fund exhibited a \$871,322 increase during the fiscal year, reaching \$2,586,345. This growth primarily stemmed from heightened stormwater grant revenues and reduced expenditure on budgeted projects yet to be completed.

Moreover, while revenue witnessed a notable surge, there was a concerted effort to manage expenses and reduce long-term liabilities. Expenses for FY23, while less than budgeted projections,


increased by 17% compared to the previous year. Payroll, constituting approximately 90% of the \$6,290,237 General Fund budget, rose by \$523,579. The city continues diminishing its long-term debt following a favorable refinancing in 2021.

Collaborative endeavors with commercial property owners and businesses yielded positive outcomes in retaining existing businesses, enticing new ventures, and fostering an uptick in retail sales. Noteworthy brands such as Gucci, Nike, Alo Yoga, and Jaxen Grey commenced operations in the Plaza, which observed a surge in foot traffic, particularly on Black Friday, marking a 20% increase over previous years. Anticipated additions of two retail stores in mid-calendar year 2024 are anticipated to occupy the Plaza almost fully, with only one retail space remaining.

The city's robust financial standing is further bolstered by revenue generated from a property tax increase, which is vital for replenishing reserves utilized during the pandemic, facilitating recent compensation adjustments, including wage hikes for all staff, and funding critical capital expenses such as the forthcoming receipt of a new Fire Engine in 2025. Additionally, these funds are pivotal in supporting a comprehensive long-range facility plan spanning 20 years currently being developed in collaboration with S.M. Wilson.

Substantial strides were taken in the realm of information technology (IT), with the implementation of a comprehensive IT strategy unanimously approved by the Board in August 2023 and the engagement of Worldwide Technology to execute a multi-year roadmap aimed at modernizing city-wide IT systems. This strategic overhaul aims to enhance customer service to residents and businesses, address TechDebt, streamline internal processes, and fortify the city's IT governance, business continuity, and cybersecurity. Simultaneously, ongoing infrastructure enhancements

on Geyer Road, the Spoede Bridge near Villa Duschesne, and a stormwater project in Countryside Lane are slated to continue through 2025. Given the volatile nature of construction costs since the onset of the COVID-19 pandemic, these infrastructure investments will bear significant weight in future budgetary considerations.

With a steadfast focus on strategic priorities, we maintain an optimistic outlook on the city's enduring financial future, ensuring its continued stability and growth.

The Fiscal year 2023 Independent Audit, the IT Strategic Plan approved by the Board in Aug. of 2023, and the Worldwide Technology multi-year roadmap are available online. Emailed or hard copies may be obtained by contacting city hall. The city revenue and expenses are also available on the city's ClearGov transparency portal on the city's website.

Garden Club: Spoede/64 Enhancements

The Frontenac Garden Club, a registered Missouri not-for-profit organization operating under 501(c)(3) status, concluded its calendar year with substantial accomplishments in and around the Spoede and Highway 64 interchange. This included the successful execution of the 2nd annual Garden Tour, spring and fall plantings and multiple impactful Trash Bashes, resulting in the collection of numerous bags of litter along the corridor. There was also a notable increase in the number of generous resident donors, contributing to an increase in the total amount of donations received.

Significant enhancements were made possible through donations, including resident Rita Diekemper facilitating the acquisition of MO sumac and additional evergreen trees from Forest Releaf of MO. Forest Releaf, dedicated to community enrichment through tree cultivation and planting, operates Project Communitree, enabling the city to access trees and shrubs at no cost. Residents can participate in the Releaf Sales program, offering quality trees and shrubs at low cost. Additional details are available at: moreleaf.org/plant.

The Frontenac Garden Club's volunteer officers, including Rita Diekemper as President and owner of Gardens of Grace, LLC. The City Administrator serves as Treasurer, overseeing financial management, while resident Sandy Gartland continues to fulfill the role of Secretary. Elizabeth Shenk and her husband Brian, founders of Treebute, have also played instrumental roles in coordinating Trash Bashes in alignment with seasonal plantings and other associated activities throughout the year.

The 3rd Garden Tour will showcase the re-invention of the American backyard. This self-guided trek will feature poolscapes and patio gardens ranging from tropical paradises to Mediterranean-inspired settings. The Garden Tour is scheduled for Earth Day, June 22, 2024, from 10 am to 2 pm. Tickets for the tour can be purchased at City Hall. Donations to the Frontenac Garden Club support community-enhancing projects, covering project costs and ongoing maintenance. efforts between the fire marshal, building commissioner, and city clerk have successfully navigated impediments to timely business openings. Concerted efforts of the building department staff have resulted in the resolution of a significant number of challenging building code issues and significantly reduced the number of related resident complaints.

In addition to continuing evidence of sales tax revenue recovery from the COVID pandemic, new initiatives of the Ways and Means committee have yielded a significant increase in investment revenue, detailed comprehensively in this newsletter edition, along with other important information on a variety of topics.

Anticipating the opportunities of 2024, we will continue to have activities commemorating the 50th anniversary of Plaza Frontenac and Le Chateau, culminating in the Fall Festival in October 2024. The collaborative efforts of the Planning and Zoning Commission, the Architectural Review Board, and the city planner remain focused on aligning land use ordinances with resident survey insights and the approved comprehensive land use plan of 2023. This concerted effort aims to delineate a collective vision for economic development that will safeguard a well-balanced blend of community and commercial. The strategic plan encompasses the reconstruction of Le Chateau and ongoing evaluations for the West End Park Commercial area, addressing pertinent floodplain concerns. Activities in 2024 will also include significant updates to the city's IT and other infrastructure that will improve key services, such as using the city website and the council chambers.

Beyond the Fall Festival, I hope to see many of you at innovative events at the Plaza, crafted to deliver a distinctive shopping experience that enriches Frontenac's legacy of gracious living, shopping, and dining. I encourage you to continue sharing your invaluable thoughts, ideas, and suggestions as we continue our efforts on substantial projects.

Building & Planning Department

We are thrilled to update you on the progress of our ongoing Zoning Code revisions. As you may recall, we have engaged the services of H3 Studio as our planning consultant to enhance and modernize our land-use regulations. These revisions aim to align our zoning codes with the newly adopted 2050 Comprehensive Plan, which serves as our roadmap for the future development of Frontenac.

We are pleased to inform you that the revisions are currently underway, and we anticipate their completion by mid-2024. Once fully adopted, these new regulations will play a crucial role in shaping future redevelopment opportunities within our community. One such opportunity is the redevelopment of Le Chateau, which is expected to undergo significant changes in the near future. The scope of this project, and others like it, will depend on how these codes are written.

We are looking forward to engaging in important discussions and seeking your input as we move forward with these changes. We will keep you informed about any public hearing notices, which will be announced prior to any zoning text amendments being approved by the City

COUNTRYSIDE STORMWATER UPDATES

We are pleased to bring you the latest update on the Countryside Stormwater Project, which aims to address flood hazards and erosion as identified in our Stormwater Master Plan. This project involves the installation of over 2,000 feet of new piping, creek restoration, and culvert replacements. The estimated cost of this endeavor is roughly \$4 million, with \$2.7 million being funded through a combination of ARPA infrastructure grants, OMCI funds provided by MSD, and federal 319 grants from the Department of Natural Resources. The remaining balance will be covered by our half-cent stormwater sales tax.

We are happy to report that significant progress has been made since our last update six months ago. The design and engineering phase has been completed, ensuring that the project is well-planned and tailored to our specific needs. Additionally, we have successfully obtained the necessary construction easements from the affected properties, representing a significant effort given the size and complexity of these improvements.

Looking ahead, our focus now shifts to the imminent construction phase. We are actively preparing to solicit construction bids, an important step that will allow us to select the most qualified contractor to bring our vision to life. This progression keeps us on track to break ground in the spring, with an anticipated completion window of Fall 2024.

We understand the significance of keeping everyone well-informed on this project as it moves forward into construction. GEYER ROAD RECONSTRUCTION

After years of planning and extensive public engagement, Phase I of the Geyer Road project is scheduled to be put out for construction bids in March, pending review and approval by the Missouri Department of Transportation (MoDOT). Once the project receives final approval from MoDOT, construction is scheduled to commence by early spring 2024. The estimated timeline for completion is approximately eight months, barring any unforeseen setbacks.

In addition to Phase I, we are also making headway with Phases II and III of the Geyer Road project. These two phases encompass the remaining areas between Steeplechase and our southern boundary near Timberwyck Drive. Currently, we have engineering work underway for both phases, keeping us on track to begin construction shortly after completion of Phase I.

We understand that construction projects can be messy and inconvenient, and we kindly ask for your patience and cooperation during this period. By staying informed and engaged, we can mitigate any disruptions and see our plans through successfully. The end result will be a revitalized and pedestrian-friendly corridor that will serve our community for years to come.

SPOEDE BRIDGE REPLACEMENT

We wanted to update you on the ongoing redesign of the Spoede Road Bridge over Deer Creek. Originally built in 1981, the current structure is nearing the end of its useful life and requires major maintenance. Construction for the new bridge is projected to take place in the summer of 2025, with a road closure during summer break to minimize school disruption. Traffic will be redirected onto Ladue, Lindbergh, and Conway Roads during this period.

It's worth noting that MoDOT will be undertaking significant roadway and pedestrian improvements along the Lindbergh corridor over the next two years, with some of that work scheduled in Frontenac in 2025. We will be closely monitoring the timeline of these improvements to minimize any overlap with our bridge project.

The new bridge will resemble the existing one but will be slightly longer. Retaining walls will be removed to create a more open creek channel, while preserving the width and pedestrian path on the east side. Efforts will be made to preserve as many trees as possible. Utilities, such as Ameren, AT&T, Spire, Missouri American Water, and Charter, will be relocated, and the project will address sanitary and storm sewer needs through a partnership with MSD. No residents or businesses will be displaced during construction.

Thanks to federal funding, approximately 80% of the project's estimated cost of \$1.5 million will be covered through the Surface Transportation Program (STP). Due to inflated construction costs, the city was able to resubmit the project for additional grant funding last year.

We appreciate your patience and look forward to providing this much-needed improvement to our community in 2025.

Fire Department Updates

As we welcome the new year, we wanted to share a few important updates on our strategic planning efforts. First and foremost, we are excited to announce that the International Organization for Standardization (ISO) has scheduled our review for February 2024. Currently, we hold an ISO rating of two (2), which is a classification achieved by less than two percent (2%) of fire agencies nationwide. This is a significant accomplishment, and we are committed to maintaining this rating in the future.


We are also thrilled to share the statistics from our Fire/EMS calls in 2023. Throughout the year, we responded to a total of 1091 Fire/EMS calls, with 493 of them related to EMS. Out of these EMS calls, we successfully completed 331 transports, ensuring that those in need received the necessary medical care. Additionally, we responded to 598 Fire/Rescue calls in 2023.

In addition to our own calls, we place great value on our dedication to supporting our neighboring departments through mutual aid calls. In 2023, we received 103 mutual aid calls for Ambulance Services (2917) and 165 mutual aid calls for the Rescue Pumper (2914). These collaborative efforts allow us to extend our reach and provide assistance wherever it is needed.

We would also like to acknowledge the response times achieved by our Ambulance Service (2917) and Rescue Pumper (2914). The average response time for the Ambulance was 1 minute and 8 seconds from the moment the call was received until the crew was out the door, with an average on-scene time of 3 minutes and 58 seconds. Similarly, the average response time for the Rescue Pumper was 1 minute and 15 seconds, with an average on-scene time of 4 minutes and 9 seconds. These prompt response times are a testament to our crew's ongoing commitment to efficiency and professionalism.

Lastly, we are excited to provide an update on the new rescue pumper, which has been ordered and is scheduled for delivery by May 2025. The addition of this new vehicle to our fleet will significantly enhance our capabilities and allow us to better serve our community.


Police Department Updates


Maintaining accreditation has always been a top priority for us, showcasing our commitment to professional policing. Achieving full accreditation in 2019 and successfully maintaining reaccreditation in 2022 reflects our dedication to operating within the highest standards and best practices. We are currently in the final year of our 3-year reaccreditation cycle, and look forward to sustaining that designation for years to come.

In 2023, our officers responded to 16,386 calls, providing the best assistance possible to each one. We filed 647 reports with an overall clearance rate of 94% for violent crimes and 36% for property crimes, demonstrating our commitment to resolving cases and keeping our community safe.

Our partnership with the West Central Dispatch Center (WCDC) is vital to our service. They answered 98.34% of 911 calls in under 10 seconds, efficiently ensuring the safety and well-being of everyone in our community. Our officers' average response time, from dispatch to the scene, was 5 minutes and 2 seconds. This allows us to offer prompt assistance when it is most needed.

Moving forward, we remain committed to providing professional and high-quality policing services to the Frontenac community. If you have any concerns, questions, or suggestions, please reach out to us.
