A. CALL TO ORDER

The February 10, 2015 meeting of the Ways and Means Committee of the City of Frontenac was called to order at 7:00 P.M.

C. APPROVAL OF AGENDA:

Chairman Winer requested approval of the February 10, 2015 agenda.

<u>MOTION</u>: Alderman O'Connell motioned and Mr. Kennedy seconded approval of the agenda. All voting members present voted in the affirmative. <u>MOTION PASSED</u>.

Chairman Winer stated he appreciated Mrs. Culleton's comments and concerns about the long term impacts surrounding the property development.

H. REVIEW OF FINANCIAL REPORTS:

January, 2015

Ms. O'Guinn gave the financial report for January stating that total consolidated Capital/General Fund revenues in January showed the city continuing to experience strong revenue performance with monthly revenue 11% higher than budget for the month. This is attributable to sales tax which is trending over 24% higher than budget in January.

Year to date we also have additional real estate tax due solely to the timing of receipts. The year to date revenue result compared to budget is 7% higher. We also have a higher permit and pilot revenues due primarily to a one time FIT tax of \$17,000, and a PILOT payment that was due last year and was received in this current year.

Ms. O'Guinn stated that projecting through the year end she could conservatively estimate that we should expect to keep a 2.6% increase of revenues over budget which is approximately \$190,000 and is a combination of a 4% lead in sales tax pilot revenues, miscellaneous revenue and permit revenue.

The operational expenses on page 4 are down 1.8% or \$76,898 year to date compared to the year to date budget.

The expense savings we expect are currently off setting legal expenses that are over budget \$24,000 year to date and Police Department overtime is also over budget by \$13,400 year to date.
